### **PETITION FOR REINSTATEMENT TO PRACTICE IN THE EASTERN DISTRICT**

Local Rule 83.3 *Attorney Discipline*, Paragraph (g) *Reinstatement* establishes the following requirements: A suspended or disbarred attorney may file a petition for reinstatement with the Clerk of the Court. The petition shall contain a concise statement of the circumstances of the disciplinary proceedings, the discipline imposed by this court, and the grounds that justify reinstatement of the attorney. That petition shall be referred to a judicial officer, and if requested by the applicant after the report and recommendation, to a three-judge panel. The Chief District Judge shall thereafter rule on the petition, absent a request by the attorney for a three-judge panel.

Attached you will find the *Petition for Reinstatement* form for use in this District. This form has been designed specifically to provide all information required for consideration of reinstatement under LR83.3(g). Please complete, sign and have notarized (as indicated), the attached form, and submit this form for filing, with the required \$201.00 filing fee, to this office. Your check should be made payable to: "Clerk, U.S. District Court."

Note: You must be a member of the Washington State Bar Association in good standing in order to petition for reinstatement in this District.
