Qualified attorneys shall have practiced law for at least three years and shall meet the requirements set forth in the District's Criminal Justice Act Plan.

As provided for in the CJA Plan for the Eastern District of Washington (please review for attorney qualifications), applications for placement on the CJA Panel will be submitted to the CJA Panel Committee. APPLICATIONS ARE DUE BY DECEMBER 31. The Panel Committee typically meets in January to review Panel applications. Prior to placement on the CJA Panel, Panel Committee recommendations for placement on the Panel are provided to the District Judges for approval.

By completing this form, you agree to be placed on a list of counsel available for appointment to represent indigent Defendants in criminal cases in this District. In most instances you would be asked to accept cases in the city which you reside; however, on rare occasions, you may be called upon to accept a case originating in another city - Spokane, Yakima, or Richland.
