The Judicial Conference of the United States, at its September 2007 session, approved a ten percent increase to the maximum original and copy transcript fee rates to be effective in fiscal year 2008, subject to the availability of funding. The Judicial Conference also approved a new rate for the delivery of transcripts within 14 days and agreed that the rate be set at the mid-point between the rates authorized for expedited (7-day) and ordinary (30-day) delivery, to be effective in fiscal year 2008. Pursuant to notice by the Administrative Office of the United States Courts, October 18, 2007, implementation of these adjustments to transcript fee rates can take effect immediately.


The judges met on October 22, 2007, and approved, by majority consensus, the ten percent rate increase and new rate for delivery of transcripts within 14 days. Now, therefore,

IT IS HEREBY ORDERED that the ten percent increase to the maximum original and copy transcript fee rates and new rate for the delivery of transcripts within 14 days, approved by the Judicial Conference of the United States, is hereby adopted by this Court. A schedule of the new transcript rates is attached. Transcripts ordered prior to the effective date of this General Order shall be billed at the rates in effect at the time the transcript order was placed.

Ordinary Transcript (30 day) A transcript to be delivered within thirty (30) calendar days after receipt of an order.	\$3.65	\$.90	\$.60
14-Day Transcript A transcript to be delivered within fourteen (14) calendar days after receipt of an order.	\$4.25	\$.90	\$.60
Expedited Transcript (7 day) A transcript to be delivered within seven (7) calendar days after receipt of an order.	\$4.85	\$.90	\$.60
Daily Transcript A transcript to be delivered following adjournment and prior to the normal opening hour of the court on the following morning whether or not it actually is a court day.	\$6.05	\$1.20	\$.90
