## Important Information and Step by Step Procedures in eVoucher for Submitting Vouchers that Exceed Compensation Maximums

There has been confusion on the procedures for requesting a waiver when case compensation exceeds the maximum amount and submitting the vouchers. Therefore, the Court has asked that the attached information and instructions be provided to CJA counsel.

The CJA 26 must be properly completed.

When case compensation exceeds the maximum, counsel first must seek a finding that the case is "extended" or "complex" through submission of the form Memorandum CJA 26 (in eVoucher).

• The amount filled in should be an estimate of the **total amount needed to complete the case**, not just covering the work to date.

• The justification **should pertain to the entirety of the case**, not just covering work to date.

If counsel believes it is necessary to exceed the previously approved amount, counsel prepares another CJA 26, again specifying a specific amount which includes the amount previously approved.

## Requirements

Payments in excess of CJA compensation maximums may be made to provide fair compensation in cases involving extended or complex representation when so certified by the presiding judge and approved by the circuit.

**Current Statutory Maximums** 

Type of Charge	Statutory Maximum
Felony Charge	\$12,100
Misdemeanor	\$3,400
Non-Capital Habeas Petition	\$12,100
Other Representations (including, but not limited to probation, supervised release hearing, material witness, grand jury witness)	\$2,600

As soon as counsel believes it will be necessary to exceed the maximum fees allowed, counsel first must seek a finding that the case is "extended" or "complex" through submission of the CJA 26 form.

Failure to provide adequate information supporting excess fees may result in the reduction of the fees to the statutory maximums.
