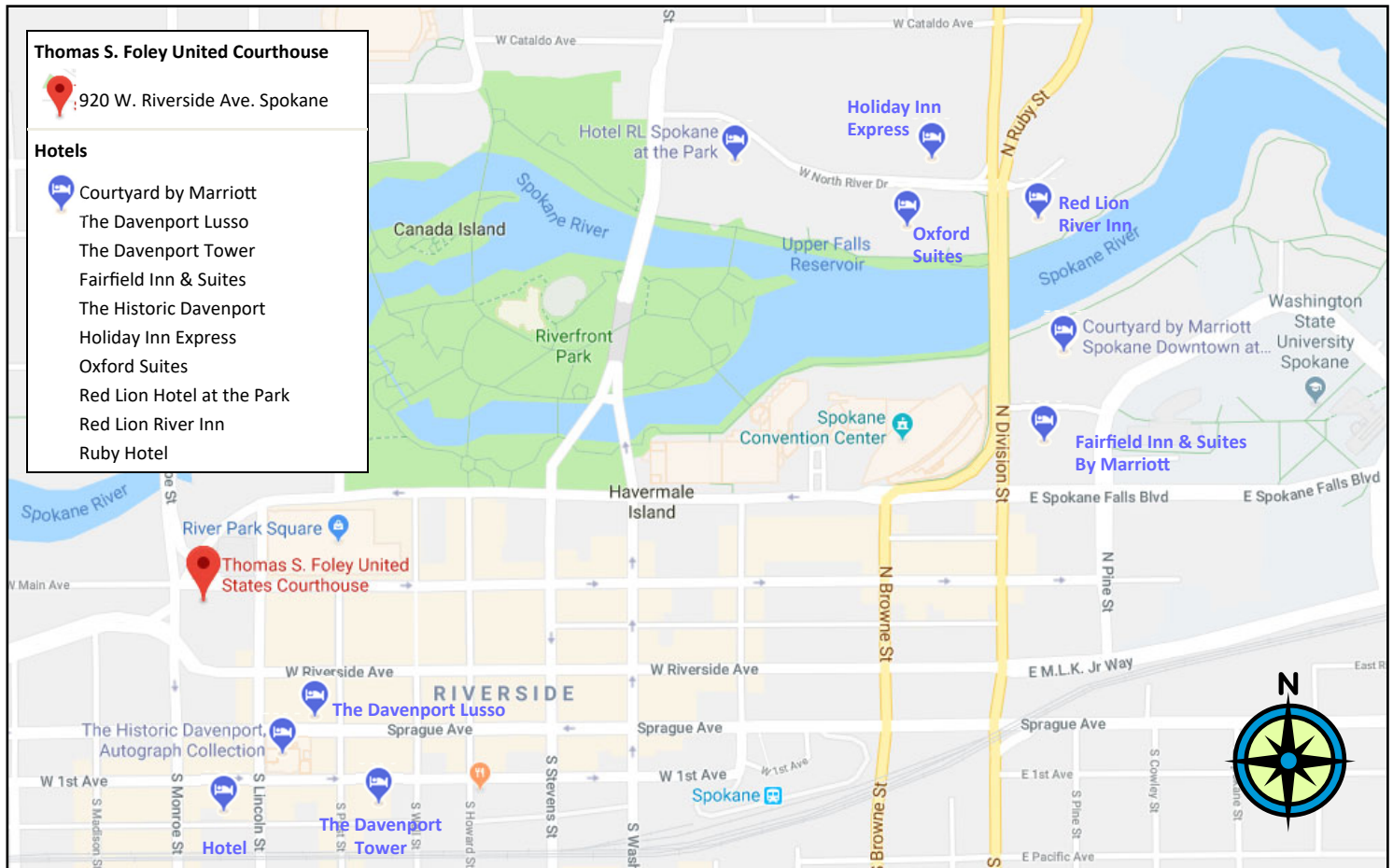


# SPOKANE LODGING

(Provided as a courtesy for jurors who live over 60 miles from courthouse)



**Overnight Per Diem:** For Jurors who reside 60 miles or more one-way from the courthouse and must stay overnight.

**Hotel Per Diem \$212.00** (\$126.00 hotel subsistence + 86.00 meals and incidentals).

**Note:** When making hotel reservations, be sure to let the hotel know you are a Federal Court juror and **request a government rate**. If lodging is in excess of the per diem, the juror is responsible for the overage. Please be prepared to show them your jury summons if needed.
