

## YAKIMA DIRECTIONS & PARKING

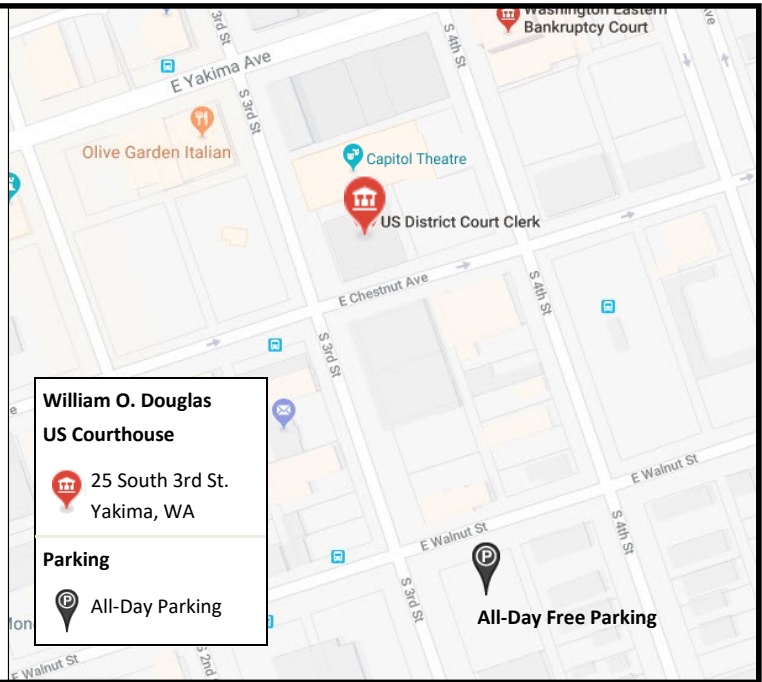
### William O. Douglas U.S. Courthouse—25 South Third Street

#### Directions:

Take Exit 33 off Interstate 82 and bear west onto Yakima Avenue. Continue on Yakima Avenue to Third Street, and turn left. The Courthouse is at the end of the block on the corner of Third Street and Chestnut. There is only one public entrance to the Courthouse, which is on Third Street at the northwest corner of the building.

#### Parking:

An All-Day FREE parking lot is located one block away, across the street from the police station at Third Street and Walnut. Please do not park at 2 hour lots as jury selection will take several hours.

**Overnight Per Diem:** For Jurors who reside 60 miles or more one-way from the courthouse and must stay overnight.

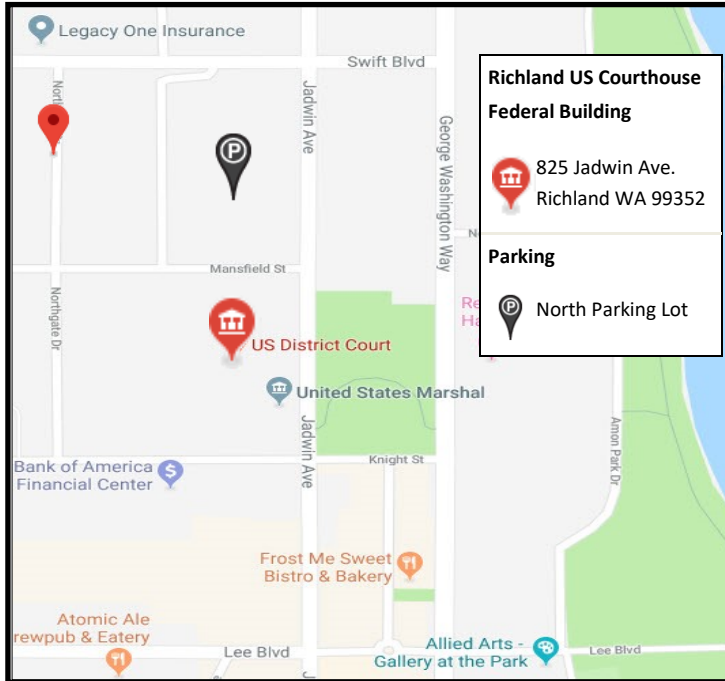
**Hotel Per Diem \$151.00** (\$96.00 hotel subsistence + 55.00 meals and incidentals).

U.S Courthouse—825 Jadwin Avenue



## Directions:

From Interstate 182 or Highway 82, take George Washington Way Exit. Turn left onto Jadwin Ave. Follow Jadwin Ave. a few blocks until you see the Courthouse on your left. (If you come to Swift Blvd. you went too far).

## Parking:

The large "permit only" parking lot to the North of the Building is available for jurors to park in without a permit for the duration of jury selection.

If selected as a juror, a temporary parking pass will be issued to you by the Clerk's Office for the duration of the trial.

**Overnight Per Diem:** For Jurors who reside 60 miles or more one-way from the courthouse and must stay overnight.
